Director Jones requested Manager Cavagnolo send a letter to Sites JPA asking about our credit balance and to check with our auditor's on how to record the Sites credit on our financials. Manager Cavagnolo will report back to the Board at the next Board meeting on what he found out. No action was taken on the January Internal Financial Statement.

WATER SUPERINTENDENT'S REPORT:

Manager Cavagnolo reviewed with the Board the Water Superintendent's report, which was included in the Board Packet. The report updated the Board on District Operations, Water Use, Deep Wells, Vehicles, and Water Quality.

MANAGER'S REPORT

A. Manager Cavagnolo reviewed with the Board his Manager's Report, which was included in the Board packet, and answered any questions the Board had.

GENERAL BUSINESS

A. The Board to receive an update on the Tehama-Colusa Canal Authority Activities

Director Jones updated the Board on the Tehama-Colusa Canal Authority activities and the meeting he participated in on 2/03/2021.

B. The Board to receive an update on the Glenn Groundwater Authority.

Director Schonauer updated the Board on the Glenn Groundwater Authority activities and meeting he participated in on 2/08/2021.

C. The Board to receive an update on current and future annexations.

Manager Cavagnolo updated the Board on the current and future annexations

Joshua Dowell, of the Orland A Farmers Group, updated the Board on a future Improvement district and annexations. Currently they have 8,500 acres to be annexed. Joshua advised the Board they might end up at 10,000 acres.

D. The Board to discuss drought year planning for the 2021 water year.

Manager Cavagnolo discussed with the Board drought year planning for the 2021 water year and the RRA requirements for Transferred water.

The Board discussed the implications of RRA on water transferred from agencies which are not paid out. Attorney Josh Horowitz explained the RRA law which says that RRA follows the water and requires land receiving the water to comply with RRA rules. Attorney Horowitz explained several options for the District, including designating water use to acres not subject to RRA and to request an exemption from Reclamation. After Board discussion, the Board reached a consensus and directed Attorney Horowitz to compose a letter to Reclamation's Regional Director requesting an exemption from this rule. The letter will be from the Board of Directors and signed by the president of the Board.

Manager Cavagnolo reviewed with the Board Resolution 2021-01, which was included in the Board packet, confirming authority to sign contract for temporary water service between the United States & OAWD providing terms and conditions are acceptable. This contract allows the District to use Section 215 Water when available. After Board discussion, it was m/s/c (Jones/Erickson) to approve Resolution 2021-01 by the following vote:
