WATER SUPERINTENDENT'S REPORT:

The Board reviewed the Water Superintendent's report, which was included in the Board Packet. The report updated the Board on District Operations, Water Use, Deep Wells, Vehicles, and Water Quality.

MANAGER'S REPORT

A. Manager Cavagnolo reviewed with the Board his Manager's Report, which was included in the Board packet, and answered any questions the Board had.

GENERAL BUSINESS

A. The Board to receive an update on the Tehama-Colusa Canal Authority Activities

Director Jones updated the Board on the Tehama-Colusa Canal Authority activities and the meeting he participated in on 5/05/2021.

B. The Board to receive an update on Glenn Groundwater Authority.

Director Schonauer updated the Board on the Glenn Groundwater Authority activities and meeting he participated in on 5/10/2021. Director Schonauer stated there is a lot of information available on their website.

Manager Cavagnolo updated the Board on the GGA/CGA Joint TAC meeting he participated in on 5/13/21.

C. The Board to receive an update on future annexations.

Chase Hurley, of the Orland A Farmers Group, updated the Board on a future improvement district and annexations. Chase advised the Board they have turned in their application and sent in a \$1,000 Application Fee. They have 16 landowners with 12,109 acres and 80% of the deeds have been collected. The directors asked how would they charge. For example,

would they pool everything or would they charge based on location (close to canal, etc.). The Board expressed concerns. Director Pieper stated the District doesn't have enough information yet. Director Erickson wants the District to charge for all of our time spent.

Chase suggested basing the deposit amount at \$5 per acre for land applied for, about \$50,000 which will be used to cover any costs to the District caused by the project. Chase informed the Board that all of the work on the project will be done by him or Provost & Prichard, who he has hired and they will be paid by his group.

After Board discussion, it was m/s/c (Erickson/Pieper) to approve our attorney, Josh Horowitz, putting together a funding agreement addressing how much of a deposit would be required which would include a replenishing clause. Manager Cavagnolo will provide a rate schedule for District staff. The vote was as follows:
