| <b>Wed., April 26<br/>(E-125)</b>                           | <b>DISTRICT TO DELIVER RESOLUTION, NOTICE OF ELECTIVE OFFICE &amp; DISTRICT BOUNDARY MAP.</b><br>District Secretary shall deliver to the County the Resolution requesting that the County Conduct the election. In addition, the District shall forward a notice containing the elective offices to be filled and whether the district or candidate is to pay for the Candidate's Statement. A map showing the current boundaries of the district shall also be delivered. EC 10509, 10524 |
| <b>Mon., May 1<br/>to Wed., May 31<br/>(E-120 to E-90)</b>  | <b>PUBLISH NOTICE OF DISTRICT ELECTION.</b><br>Between these dates the Elections Official/District Secretary of the principal county will publish a Notice of Election once in a newspaper of general circulation setting forth the date of the election, elective offices to be filled, qualifications, location where declarations of candidacy may be filed and the deadline for filing. | <b>Mon., May 8<br/>to Fri., June 2<br/>(E-113 to E-88)</b>  | <b>CANDIDATE NOMINATION PERIOD.</b><br>Nomination papers are filed with the district secretary. EC 10510   |
| <b>Fri., June 2<br/>(E-88)</b>                              | <b>CANDIDATE WITHDRAWAL.</b><br>Last day a candidate may withdraw a Declaration of Candidacy. EC 10510   |
| <b>Sat., June 3<br/>To Wed., June 7<br/>(E-87 to E-83)</b>  | <b>EXTENDED NOMINATION PERIOD.</b><br>Ends June 7, 2023. Open for non-incumbents, only when the qualified incumbent does not file candidate papers for the same office. EC 10516   |
| <b>Thurs., June 7<br/>(E-83)</b>                            | <b>INSUFFICIENT NOMINEES.</b><br>If by 5:00 p.m., no one has been nominated or an insufficient number of persons have been nominated to fill offices, and a petition signed by 10% or 50 voters, (whichever is smaller) has not been submitted, then a person who has filed a Declaration of Candidacy shall be appointed by the Board of Supervisors. If no one files then another qualified person shall be appointed and take office as if they were elected. EC 10515                  |
| <b>Mon., July 3<br/>to Tues., Aug 15<br/>(E-57 to E-14)</b> | <b>WRITE-IN CANDIDACY.</b><br>Period during which write-in candidates may file candidate papers.   |
| <b>Thur., July 20<br/>(E-40)</b>                            | <b>FIRST PRE-ELECTION STATEMENT.</b><br>Deadline for candidates <u>who will appear on the ballot</u> to file a first pre-election campaign contributions and expenditures disclosure statement.  |
| <b>Tues., July 25<br/>(E-35)</b>                            | <b>LIST OF QUALIFIED VOTERS</b><br>No later than this date, the District Secretary shall prepare a list of qualified voters and provide it to the County. EC 10525   |
| <b>Thurs., August 17<br/>(E-12)</b>                         | <b>SECOND PRE-ELECTION STATEMENT.</b><br>Deadline for candidates <u>who will appear on the ballot</u> to file a second pre-election campaign contributions and expenditures disclosure statement.  |
| <b>August 29, 2023</b>                                      | <b>ELECTION DAY</b>  |
| <b>December 1, 2023</b>                                     | Elected and appointed candidates take office. (Except Levee Districts) EC 10554  |
| <b>January 8, 2024</b>                                      | Elected and appointed Levee District candidates take office. WC 70071  |
