(E-88)	Last day a candidate may withdraw a Declaration of Candidacy. EC 10510
Sat., June 3 To Wed., June 7 (E-87 to E-83) Thurs., June 7	EXTENDED NOMINATION PERIOD.  Ends June 7, 2023. Open for non-incumbents, only when the qualified incumbent does not file candidate papers for the same office. EC 10516  INSUFFICIENT NOMINEES.
(E-83)	If by 5:00 p.m., no one has been nominated or an insufficient number of persons have been nominated to fill offices, and a petition signed by 10% or 50 voters, (whichever is smaller) has not been submitted, then a person who has filed a Declaration of Candidacy shall be appointed by the Board of Supervisors. If no one files then another qualified person shall be appointed and take office as if they were elected. EC 10515
Mon., July 3 to Tues., Aug 15 (E-57 to E-14)	WRITE-IN CANDIDACY. Period during which write-in candidates may file candidate papers.
Thur., July 20 (E-40)	FIRST PRE-ELECTION STATEMENT.  Deadline for candidates who will appear on the ballot to file a first pre-election campaign contributions and expenditures disclosure statement.
Tues., July 25 (E-35)	LIST OF QUALIFIED VOTERS  No later than this date, the District Secretary shall prepare a list of qualified voters and provide it to the County. EC 10525
Thurs., August 17 (E-12)	SECOND PRE-ELECTION STATEMENT.  Deadline for candidates who will appear on the ballot to file a second pre-election campaign contributions and expenditures disclosure statement.
August 29, 2023	ELECTION DAY
December 1, 2023	Elected and appointed candidates take office. (Except Levee Districts) EC 10554
