## RESOLUTION DETERMINING GROSS ASSESSED VALUE AND FIXING AND ORDERING ASSESSMENT

AS A BASIS AND PREMISE for this Resolution, the Board of Directors of ORLAND-ARTOIS WATER DISTRICT finds and states as follows:

- 1. The Annual Estimate and the Assessment Book of ORLAND-ARTOIS WATER DISTRICT has previously been filed with this Board.
- 2. Notice of the time and place of a hearing upon such assessments before this Board, meeting as a Board of Equalization, has been given according to law.
- 3. A hearing before this Board, meeting as a Board of Equalization, was held on this date.
- 4. There having been no objections made to the assessments as the same appear in the Assessment Book, and there being necessary no changes or additions to the Assessment Book,

### NOW, THEREFORE, be it RESOLVED, ADJUDGED and ORDAINED that:

- 1. The assessed valuation of all the lands in ORLAND-ARTOIS WATER DISTRICT, as shown in the Assessment Book duly prepared by the Assessor of the District, is the proper assessed valuation of each parcel of such lands for the purposes of the District. The assessed values of those parcels correctly and accurately reflect the proportional benefits bestowed upon each parcel by the existence and operations of the District
- 2. The total amount of land in ORLAND-ARTOIS WATER DISTRICT subject to assessment under Section 36576 of the California Water Code is 28,918.01 acres.

3. In accordance with the reasons set forth above, and in Resolution No. 2019-10 of the Board of Directors of ORLAND-ARTOIS WATER DISTRICT; in view of the benefits conferred upon and received by the property assessed because of the existence and operation of the District; and, in consideration of the financial obligations of the District including, but not limited to, repayment obligations for capital improvements serving the lands, the following special benefit assessment is hereby fixed:
